BE WARY OF PHISHING ATTEMPTS

Scammers frequently send messages within these apps to steel personal and financial information from other users. Don't respond to these messages — and under no alrourestonces should you follow any lines they contain. Check for spetting errors as self as inspecting the name of the sender. Report any suspected philining emails to the opp's help center—and notify your bank if you think your financial information.

CHECK REVIEWS

Take time to read the reviews and comments left by other users - not just of products but of sellers and buyers, to ensure they re logitimate and reliable. Before buying an bern entire, check the reviews to comments about the product's quality, the seller's communication and the delivery time. If you selling, check the reviews of your buyer for red flags such as frequent requests for refunds or claims of 'missing' items.
